

SAUDI SOCIETY OF PERIODONTICS CASE PRESENTATION COMPETITION

Out of the desire of the Saudi Society of Periodontology (SSP) to spread knowledge and increase the level of clinical excellence among periodontists, the SSP scientific committee decided to run this scientific challenge among the future general dentists and periodontal residents on an annual basis by hosting a case presentation competition.

REGULATIONS ARE ENLISTED FOR EACH CATEGORY AS BELLOW: CATEGORY B:(POST GRADUATE TRAINING PROGRAMS RESIDENTS, MASTERS AND DOCTORAL DEGREES)

- 1-Participants must hold a current active membership of the SSP prior to submitting his/her case.
- 2-Case must be submitted in PDF format(following specific format that can be uploaded on the SSP website) sent to theSSP official email () prior to deadline (), cases submitted after deadline will NOT be included in the filtering phase.
- 3-Applicants must sign a consent allowing for the future possible use of the case presentation content on social media and other announcements. If the case was treated by the candidate at their schools during their residency program, the form should be co-signed by the supervising faculty.
- 4-All cases must follow the criteria of case selection for this category, failing to do so, will result in excluding the participant from the competition.
- 5-Applicants must select one case to submit, we urge all to use their best available cases.
- 6-The competition is open for all periodontal residents and junior periodontists (up to 3 years after completion of residency training)Nationally and Internationally.
- 7-Decisions made (by the selection committee) for the top three winners are considered final and changes cannot be made of overruled.
- 8-Presenters needing to include extraoral photos due to its importance in their case management are required to provide a written consent from the patient (if above 18 years old) or one of the patient's parents if below this age.
- 9-Cases will be judged based on excellence in providing accurate diagnosis, following treatment plan phases and showing a complete treated case reaching to final phase(maintenance phase).

10-case requirements are listed below:

a- pre and post-operative intra-oral photos(frontal MIP, Lateral andocclusal)

Note: Participants are free to share specific photos to demonstrate a specific challenge, technique or surgery if they believe it brings an extra demonstrative value.

b-OPG/ panoramic radiograph and full mouth radiographs before and after treatment.

c-Photos of articulated diagnostic casts are very necessary with diagnostic waxing if the case requires it.

d-Participants are required to provide at least two treatment plans (Ideal and working treatment plan) start with proposing the ideal option first.

e-Participants are encouraged to use clear photos and diagnostic radiographs as this plays a major role in reaching proper diagnosis.

f-Each case must be finished cases that is either multidisciplinary comprehensive cases (at least 3 disciplines) or fully documented periodontal cases.

Note: Management of biofilm induced gingivitis will not be accepted as treatment under the Periodontics discipline.

Note: Periodontal specialty has to be surgical periodontal treatment such as pocket reduction surgery, resective/regenerative, soft tissue or implant surgery.

Note: Participants are also encouraged to use an electronic periodontal chart for clarity purposes and must include probing depths, bleeding on probing, root recession, clinical attachment loss, furcation and mobility or fremitus if any.

g-Participants are expected to implement evidence-based practice and are encouraged to include scientific evidence in their presentations in the form of updated literature if and when needed.

h-Case must be managing permanent dentition, no primary teeth to be included, unless retained in adult case and to be addressed in the case treatment.

I- In addition to the scientific content, case documentation,treatment phasing, outcome of treatment provided, participants will also be evaluated for their presentation skills and attitude.

PHASES OF COMPETITION

1-PHASE ONE:

Cases are submitted to the assessment committee to insure its eligibility to participate in the competition. Note only the first 100 case will be accepted.

(Assessment/selection will be done purely by the committee)

2-PHASE TWO:

Assessment committee will filter the initially accepted applications and select top 30 application.

(Assessment/selection will be done purely by the committee)

3-PHASE THREE (SEMI-FINAL PHASE):

Semi-final phase selected applicants will be assigned a specific date and time to present online (the names of selected applicants, date and time will be announced on official website and SPP social media accounts) ahead of time. Six applicants will be asked to present in a day for consecutive 5 days. Each day only top applicant will move to the final level.

(Selection will be based on the final score awarded (out of 100). 50% of the final grade is score will be awarded by the evaluation committee and other 50% will be based on voting by SSP viewer members).

4-PHASE FOUR (FINAL PHASE):

The final 5 selected candidates will be assigned a specific date and time, to compete by presenting their cases. Additionally, they SSP members voting will be opened and applicants will be given a series of questions at the end of the session.

(Selection of the top 3 ranks, will be based on a total score (out of 100). The total score is composed of committee's judgment (50%), SSP members voting (30%) and (20%) on the questions.

AWARDS FOR THE WINNERS

1-Certificificates of excellence in recognition of the hard work will be awarded from the SSP president along with one-year free SSP membership.

2-Monetary prizes will be awarded to the top three ranks. First rank will be awarded 5000 SR, 2nd rank 3000 SR and 3rd rank 1500 SR.

3-The 1st winner of the competition will be given a chance to present his/her case at one of the SSP main events.

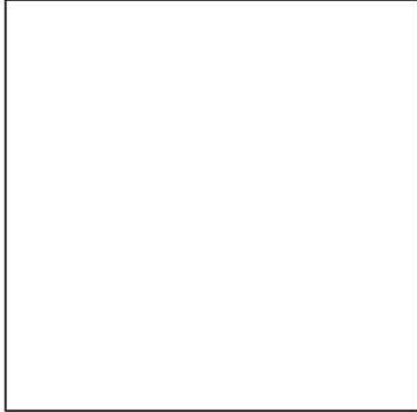

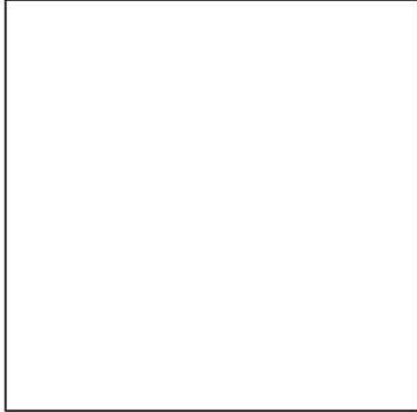
